Call to Order

Chairman Carmichael called the March 8, 2022, Regular Meeting of the Perkins County Commission to order at 10:00 am.

Approval of the Agenda

Monthly Reports

- Finance Officer's Account with the Deputy Finance Officers to the Honorable Board of County Commissioners of Perkins County: I hereby submit the following report of my examination of the cash and cash items in the hand of the Deputy Finance Officers of this County as of February 28, 2022, Sylvia Chapman Finance Officer, Perkins County. Total deposits in bank \$2,559,433.35, Total amount of actual cash \$200.00, Dakota Plains Federal Credit Union \$103,976.76, Certificates of Deposits \$400,000.00, Total \$3,063,610.11. The total amount represents state, county, schools, cities, and township funds to be transferred to various entities of government after being apportioned.

Highway Superintendent

- Highway Superintendent Green presented the Monthly Report for March. The crew is busy doing maintenance on packers, pickups, motor graders and other equipment. Bridge maintenance and signage will proceed as weather permits. The load limits on county roads have been posted. Spring blading will begin when conditions are right.
- Green presented a proposed agreement with Game Fish & Parks on the maintenance of the Corps of Engineers roads which extend to the east of West Cabin Site Road, C2A. A proposal will be reviewed at the next commissioner meeting.
- Green would like to piggy-back off the Beadle County True North Steel Bid. Foster moved, Henderson seconded to piggy-back off the Beadle County True North Steel Bid, motion carried. The complete bid with the minutes from Beadle County is on file at the Perkins County Finance Office.

Resolution 2022-04 Bridge Reinspection Program Resolution

Schweitzer moved, Campbell seconded to introduce and approve Resolution 2022-04 "Bridge Reinspection Program Resolution"; roll call vote: Henderson aye, Foster aye, Campbell aye, Schweitzer aye, Carmichael aye, motion carried.

Resolution 2022-04 Bridge Reinspection Program Resolution For Use With SDDOT Retainer Contracts

WHEREAS, Title 23, Section 151, United States Code and Title 23, Part 650, Subpart C, Code of Federal Regulations, requires initial inspection of all bridges and reinspection at intervals not to exceed two years with the exception of reinforced concrete box culverts that meet specific criteria. These culverts are reinspected at intervals not to exceed four years.

THEREFORE, Perkins County is desirous of participating in the Bridge Inspection Program using Bridge Replacement funds.

The County requests SDDOT to hire Brosz Engineers, Inc (Consulting Engineers) for the inspection work. SDDOT will secure federal approvals, make payments to the Consulting Engineer for inspection services rendered, and bill the County for 20% of the cost. The County will be responsible for the required 20% matching funds.

Surplus Property

ARPA Funding

Jennifer Sietsema was present to visit with the Commission on the Final Ruling on the ARPA Funds. Perkins County has opted to take the standard Revenue Loss of \$10 million. ARPA Funds can now be used for "any government service".
