If possible, they would like the Commissioners to sign a letter of support along with giving them the opportunity to request funding in the future.

11:45 a.m. GF&P - Rifle Range

Jim Straight along with Keith Mutschler and Ryan Halls were present to discuss with the Commissioners a potential Rifle Range south of Lemmon's City Dump. GF&P (Game, Fish & Parks) would like it to be done in phases. Phase 1 would include a 50-yard, 100-yard, 200-yard range and Phase 2 would include a 300-yard and 500-yard range with potential for a shooting sports building. Currently looking at engineers to eventually let out bids. They do not want to charge membership fees and want to have set hours with rules posted – which would be the same as across the state. The lease holder would be GF&P and would most likely be on a 25-to-35-year lease.

- Added Taxes Previous DOE Corina Kocer had spoken to Camavision about how to assess
 these old schools that have been purchased. They put a taxable value of \$50,000 on it for
 next year's taxes. Interim DOE Todd Lutters was asked by the Commissioners to assess
 the value of the portion of the building occupied by Headstart. The taxable value for that
 portion would be \$795.00. Commissioners decided not to pursue an added tax bill for this
 year.
- <u>Easter Monday</u> Schweitzer moved, Campbell seconded to give all Perkins County Employees an extra paid Holiday on April 1st, 2024 for Easter Monday due to Governor Noem giving all state employees the day off, motion carried.
- Abate, Appraise, Surplus, Advertise #17525 & #13279 Foster moved, Henderson seconded to abate taxes, appraise the value of the house and lot as is, surplus the property and anything located on it, and advertise for sale Record #'s 17525 & 13279, motion carried. The 3 real property owners appointed by Chairman Carmichael to appraise the value will be Todd Campbell, Mike Schweitzer, and Neal Pinnow.
