### 10:15 a.m. Roxie Seaman – Wind Farms

Roxie Seaman & Vaughn Meyer were present to encourage the Commissioners to implement zoning ordinances within the County to discourage the building of Wind Farms.

<u>10:50 a.m. Jerome Erhart</u> – Amy with Dakota Guardianship was appointed Guardian & Conservator of the person and estate of Jerome Erhart and wished to address with the Commissioners the possible sale of the house owned by Jerome Erhart, Record #13530. Amy reported that Jerome's house was sold at auction for \$12,500 and after paying necessary fees would be able to pay remaining balance of \$8,000 to Perkins County in exchange for all the liens on the property, which equal to \$29,883.72. Foster moved, Henderson seconded to accept the \$8,000 in exchange for the liens due to ongoing medical expenses of Jerome Erhart, motion carried.

<u>Perkins County Wages</u> – Commissioners discussed the possibility of decreasing positions to be able to provide raises for some current employees.

<u>Black Hills Council Ordinances</u> – Commissioners discussed possibly placing Wind & Solar Ordinances within Perkins County. Commissioners will do more research on what other Counties within the State do. Commissioners are interested in hearing from Black Hills Council of Local Governments for their input and would be interested in a further meeting.

Highway Superintendent

- ✓ Highway Superintendent Green presented the Monthly Project and Maintenance Report for the month of April. Green reported that the 2006 John Deere has seals that went out of the tandems and is currently in Rapid City getting repaired. One of the Cat Graders has a header out. The 2018 pickup that Superintendent Green drives had the transmission go out on it. Green also reported blading of roads started on April 17<sup>th</sup>.
- ✓ <u>Airport Rd</u> was discussed. Some of the road is broken up and getting worse. Green will look into this further and discuss with the City of Lemmon on possibilities.
- <u>Resignation Isaac Jones</u> terminated employment with the County on April 20<sup>th</sup> to work for the City of Faith.
- ✓ <u>Bridge Inspection</u> Foster moved, Campbell seconded to pay Brosz Engineering for the 20% share on the Bridge Inspection Work Order and authorize Cody Green as the signatory, motion carried.
- ✓ Foreman Position Henderson moved, Foster seconded to give newly appointed Foreman Bailey Escott an hourly wage of \$19.99 effective May 1, 2023, motion carried.
- <u>County Shop Power Quote</u> Superintendent Green received a quote from James Sandgren to diagnose and repair and reduce the number of meters at the shop by 1.
- ✓ <u>Gooseneck Implement Quote</u> Superintendent Green stated that the 2003 7220 has solenoids out again and received a quote from Gooseneck Implement to trade ours in for a trade in value of \$40,000 with the mower attachment and lease a new one for 3 years at \$4,800 per year. At the end of those 3 years we would have the option to buy it at \$64,975.
- <u>CDL Policy</u> Superintendent Green would like to implement a CDL Policy for new hires. He will work with the States Attorney to draft one.
