## Introduction

**Snow Removal Procedures** 

The following information is intended to serve as general guidelines for addressing snow removal operations in Perkins County. It reflects the dual goals of efficiently clearing County roads while protecting the safety of the public and the county employees.

This manual contains general statements of policies and procedures. It should not be read as including fine details of each policy or procedure. In addition, the policies and procedures may not be applied in all cases.

Perkins County may change or add to the policies and procedures from time-to-time. There may be situations where amendments are made before this document can be updated.

# Policy Enforcement and Implementation

Snow Removal Procedures

To the extent that any previous rule, regulation, policy or past practice, written or unwritten, is in conflict with the provisions of this policy, such is hereby withdrawn, voided and all personnel should conduct themselves in conformity with the policy. This policy is not intended to create any duty to any individual member of the public or to protect any particular or circumscribed class of persons. All or parts of this policy may be affected by at least one or more of the following situations that will delay all or some of the services provided:

- Equipment breakdowns
- 2. Vehicles disabled in deep snow
- 3. Weather so severe as to cause crew to be called in from roads, i.e., whiteout conditions
- 4. Equipment rendered inadequate by the depths of snow or drifts
- Crew breaks, and breaks required for refueling, refilling of material spreaders, and installing chains or new blades, and
- 6. Unforeseen emergencies

## **Policy Statement**

Snow Removal Procedures

It is the policy of Perkins County to initiate snow removal operations to maintain traffic as long as visibility is above minimum, and weather conditions are such that plowing can be done safely and effectively.

# Responsibilities and Considerations

The Perkins County Highway Department Superintendent or his assignee has the responsibility for initiating all snow removal actions using his best judgment and considering several factors, including but not limited to:

- 1. Prevailing weather conditions
- 2. Amount of snow fall
- 3. Type of snow fall
- 4. Areas affected and
- 5. Emergency or extreme conditions

The Perkins County Commissioners, Highway Superintendent and Highway Foremen will have the responsibility, in a declared emergency, to coordinate all emergency situations.

## **General Practices**

## Perkins County Highway Department

#### Snow Removal Procedures

- 1. When the snowfall is at least 3 inches, but less than 6 inches, all hard surface roads will be plowed during normal working hours.
- 2. With a snow fall of 6 inches or more, all gravel roads as well as hard surfaced roads will be plowed during normal working hours.
- 3. A snowfall of 6 inches or more may result in plowing activities being conducted before and after normal working hours, as well as weekends and holidays.

#### Priorities:

- a. Paved Roads: C-09, C-09A, C-25, C-02, C-19
- b. School Bus routes on gravel
- c. Mail Routes
- d. Remaining County Roads
- e. Unorganized Township Roads (as needed)

County snow crews will not clear private driveways or private property, except in an emergency. Snow placed in a driveway or on sidewalks by County plows where driveway or sidewalk meets the road is the responsibility of the property owner to remove.

## **Sanding Policies**

The Perkins County Highway Department has been directed to sand/salt areas designated by the County Commission, such as:

- · Bridge approaches
- Curves
- Steep hills
- · Hard surfaced road intersections on the County Highway system

Other sites may also be sanded/salted, including:

- High traffic volume areas
- Accident or emergency vehicle danger areas, as identified by the County Sheriff's Department; and
- Other locations identified by the Highway Superintendent or Highway Department personnel

The Perkins County Highway Superintendent or his assignee has the authority to sand/salt before and after normal working hours, due to adverse weather conditions.

## Release

This form is to be distributed to all County Highway Shops for use in vehicles that may encounter stalled or disabled vehicles. It should be signed by the owner operator of the vehicle before any towing activities are undertaken.

Blading and Mowing Procedures

The following information is intended to serve as general guidelines for addressing Blading and Mowing operations in Perkins County.

Perkins County will Blade and Mow Ditches as follows:

#### 1. All County Paved Roads

Bixby Rd- 36.2 miles

Theater Rd-1mile

White Butte Rd- 32 miles

Gregorian Rd-1 mile

Summerville Rd- 2 miles

Railway Rd- 3.6 miles

Airport Rd-1 mile

Total miles- 76.8 miles

#### 2. All County Gravel Roads

Total miles- 474.7 miles

## 3. Secondary Roads (Through Roads)

Boarderline Rd- 1 mile Fredlund Rd (Pleasant Valley TWP)- 4.5 miles

162<sup>nd</sup> Ave- 4 miles 134<sup>th</sup> Richland- 7 miles

Lodgepole Rd- 10 miles 136<sup>th</sup> Sunnyside- 5 miles

113<sup>th</sup> St- 2.5 miles Hover Zeona Rd- 2 miles

163<sup>rd</sup> Ave- 3 miles Lilly Creek- 6 miles

Holland Center Rd- 2.75 miles Cottonwood- 6 miles Ridgeview Rd- 5.5 miles

Butcher Creek- 3 miles

Total miles-58.75 miles

<sup>\*</sup>Secondary Through Roads will get bladed and mowed 1 time a year. \*

### 4. Secondary Roads (Driveways)

Total miles- 203.3 miles

\*All rest of Secondary Roads will be bladed and mowed if time permits to do so. \*

It will be at the discretion of the Highway Superintendent or the Highway Foreman to decide if such Secondary Road will be deemed to be bladed or mowed that year if time permits to do so.
