A RESOLUTION ADOPTING THE PERKINS COUNTY
COMPREHENSIVE PLAN**

WHEREAS, South Dakota Codified Law 11-2-11 states that "The county planning commission may prepare, or cause to be prepared, a comprehensive plan for the county";

AND WHEREAS, the Perkins County Planning Commission has carefully considered the Perkins County Comprehensive Plan, which identifies the Planning Commission's recommendations for protecting and guiding the physical, social, economic, and environmental development of the county;

AND WHEREAS, the Perkins County Planning Commission has held a public hearing in accordance with South Dakota Codified Law 11-2-18, and has recommended approval to the Perkins County Commission of the Perkins County Comprehensive Plan;

AND WHEREAS, the Perkins County Commission has held a public hearing in accordance with South Dakota Codified Law 11-2-19 and has carefully considered the recommendation of the Perkins County Planning Commission for the adoption of the Perkins County Comprehensive Plan;
