Call to Order

Chairman Carmichael called the Special Year End Commissioner Meeting to order at 10:00 a.m.

Pledge of Allegiance

The Pledge of Allegiance was recited by those in attendance.

Conflict of Interest

There was no Conflict of Interest to declare.

Approval of the Agenda

Foster moved, Campbell seconded to approve the Agenda as presented, motion carried.

Commissioners Contingency Transfer

Foster moved, Schweitzer seconded to do a Contingency Transfer from the Commissioners Contingency Fund 101-112-429 for \$4,000.00 to the Coroner Professional Services fund 101-213-422 for \$2,000.00 and to the 911 Communication Center Fund 207-225-422 for \$2,000.00, motion carried.

Tracy Collins – Prairie City Road

Mr. Collins was present to question and request what work could be done on the Prairie City Road to improve it. Concerned citizens voiced that when moisture is present the road is impassable. Commissioners appreciated the concern and will look at adding gravel to a section of the road to see if there is any improvement.

2026 HRA Reimbursement

Henderson moved, Schweitzer seconded to set the HRA (Health Reimbursement Arrangement) reimbursement for 2026 at \$10,000 for employee only policies and \$20,000 for all other policies, after employees meet the \$1,100/\$2,200 deductible for the 2026 Health Insurance Plan Year, motion carried.

2026 Health Insurance Employee Costs

Finance Officer Stadler wanted to inform the Commissioners of the decreased costs that employees will be contributing to their portion of the health insurance.

2026 Current Connection Contract

Campbell moved, Henderson seconded to approve the 2026 contract for IT services with Current Connection and authorize Finance Officer Stadler as the signatory and to increase the suggested security software for 2026, motion carried.
