#### Highway Department - Cody Green

Superintendent Green presented the Commissioners with his Monthly Report for the month of April. The crew has been working on maintenance and repairs and blading and pulling shoulders.

- Motor Grader options Fix, Buy Used, Lease New Superintendent Green reported that the 2001 Caterpillar Motor Grader is needing its transmission replaced again. Green collected quotes from CAT Butler and RDO. After much discussion, the Commissioners determined the best choice was to repair the current Motor Grader through CAT Butler with a quote of \$16,580. Commissioner Schweitzer was called during this discussion.
- <u>Classification for County & Secondary Roads</u> Superintendent Green presented the Commissioners with his update on the County and Secondary Roads schedule. Henderson moved to update the Perkins County Snow Removal, Blading, and Mowing Procedures Handbook with the suggested updates from Superintendent Green, motion carried.
- <u>Donation of Sick Leave</u> Recent hire Joseph Aukland recently had a child, and has exhausted his sick leave and vacation benefits, so asking Commissioners to allow employees to donate sick leave to him. Foster moved, Henderson seconded to allow any employees interested in donating sick leave to Joseph Aukland, motion carried.

<u>Director of Equalization – Tracy Hafner</u>

- <u>Discretionary</u> Director of Equalization Tracy Hafner consulted with the Commissioners about their thoughts on how the current discretionary is applied. It was decided to keep doing it as it has been done.
- Wage Increase
  - Tracy Hafner has completed her test to be a Certified Appraiser Assessor (CAA) for the Director of Equalization office. Foster moved, Henderson seconded to set Tracy Hafner's annual base wage at \$52,346.23 effective April 7<sup>th</sup>, 2025, motion carried.
  - Misty Jorgensen has completed her test to be a Certified Appraiser Assessor (CAA) for the Deputy Director of Equalization position. Foster moved, Henderson seconded to set Misty Jorgensen's base wage at \$20.39/hour effective April 7<sup>th</sup>, 2025, motion carried.

<u>Increase Internet Speed</u> – DOE Hafner has had issues with the GIS website not uploading in a timely fashion. After testing an internet upgrade through WRCTC, our monthly cost will increase approximately \$40/month.

<u>Sheriff Kelly Serr – Jail Policy Annual Review</u> – Sheriff Serr wanted to let the Commissioners know that he is working on updating the Jail Policy book and also wanted to let the Commissioners know that the SDPAA pool has had training for Jail Staff, motion carried.
