Monthly Reports

- Finance Officer's Account with the Deputy Finance Officer To the Honorable Board of County Commissioners Perkins County: I hereby submit the following report of my examination of the cash and cash items in the hands of the Deputy Finance Officer of this County as of January 31, 2024, Sara Stadler, Finance Officer, Perkins County. Total amount of deposits in banks \$2,419,387.25, Total amount of actual cash \$200.00; Dakota Plains Federal Credit Union: \$106,215.52; Certificates of Deposit \$402,626.68; Total \$2,928,429.45. The total represents state, county, schools, cities and township funds, which will be transferred to each entity of government after being apportioned. Finance Officer Stadler also informed the Commissioners that the original Fund Balance Report for last month was slightly off due to Spreading the Interest incorrectly. The error was \$6,136.52, which affected the General Fund. Legislative Audit expressed letting the Commissioners know.
- Sheriff's Fees in the amount of \$535.52 were reviewed.
- Motor Vehicle fees for the month of January 2024 were reviewed.
- Register of Deed's fees in the amount of \$3,558.50 were reviewed.
- Longevity increase of .10/hour will be realized for the following: H. Stevens 2-6, C. Green 2-24.

SB201 – Resolution 2024-03 for Local Control

Roxie Seaman was present on behalf of Rebecca Paul to discuss SB201 with the Commissioners. Foster moved, Schweitzer seconded to sign Resolution 2024-03, "Resolution for Local Control," Roll Call: Henderson aye, Campbell aye, Foster aye, Schweitzer aye, Carmichael aye, motion carried.

Resolution 2024-03 Resolution for Local Control

WHEREAS, Local control of government functions is a key principle of the United States of America and the State of South Dakota, and

WHEREAS, South Dakota has a long history of allowing counties, municipalities, and townships to adopt local zoning ordinances that benefit local jurisdictions and the citizens they serve, and

WHEREAS, Legislation limiting the ability of local governments to evaluate and regulate compatible land use would by extension interfere with the opportunity for local citizens to have a voice in local planning and zoning matters, and

WHEREAS, the board of Perkins County Commissioners continues to support counties, municipalities and townships having authority to adopt appropriate regulations for each unique jurisdiction, and

NOW, THEREFORE, BE IT RESOLVED that the Commissioners of Perkins County state for the record that it opposes any legislation that limits or eliminates the local control of counties, municipalities, and townships in matters related to and including planning and zoning, and

BE IT FURTHER RESOLVED that this body believes in earnest that the State's motto, "Under God the People Rule" stands steady against the current belief by some that government is a "top down" system. Instead, it specifies the voice of the people, not their representative's rule, especially when coupled with Abraham Lincoln's famous words from the Gettysburg Address, which, in part, says, "... and that government of the people, by the people, for the people, shall not perish from the earth".

Highway Department

Superintendent Green presented the Commissioners with his Monthly Report for the month of January. He reported on continuing with maintenance and repairs and is currently working on signage and tree trimming. Superintendent Green wanted to let Commissioners know that Spring Load Limits will be in force March 4th thru May 2nd.

<u>Set Gravel Rates</u> – Superintendent Green would like to leave the rates the same for 2024: Gravel \$6.00/Ton, Gravel to Private Individuals \$6.30/Ton, Chips \$12.00/Ton, Sand at \$6.00/Ton. Foster moved, Campbell seconded to leave at Superintendent Green's discretion, motion carried.

2024 Skidsteer - Foster moved, Henderson seconded to rescind the motion from the January 23, 2024 meeting to purchase the 2024 Kubota from Lindskov Implement with 74-inch bucket (with orange protection program) and trade in the 2007 Bobcat for \$18,000, at a total cost of \$54,319.87, motion carried. Foster moved, Campbell seconded to purchase the Kubota (SVL75-3HWC) from Butte County Implement through the state Sourcewell Contract, at a purchase price of \$52,842.93, which includes Base Price of

<u>Joint Power & Funding Agreement – Bridge 53-281-151</u> – Foster moved, Schweitzer seconded to rescind the motion made on 12-12-2023 for Joint Powers & Funding Agreement for Bridge Replacement between SD Dept. of Transportation and Perkins County, motion carried. Foster moved, Campbell seconded to authorize Chairman Carmichael as the signatory on the updated Joint Powers & Funding Agreement for Bridge Replacement dated 1-2024, motion carried.

<u>2024 Bridge Inspection Resolution</u> – Superintendent Green presented 2 different resolutions for the Commissioners to look at. Commissioners would like Superintendent Green to research other engineering firms to see if we could bring in cheaper quotes or other options. Superintendent Green researched during the rest of the meeting. Foster moved, Schweitzer seconded, to sign Resolution 2024-05 "Bridge Reinspection Program Resolution for Use with SDDOT Retainer Contracts", Roll Call: Campbell aye, Schweitzer aye, Henderson aye, Foster aye, Carmichael aye, motion carried.

Resolution 2024-05 Bridge Reinspection Program Resolution for Use with SDDOT Retainer Contracts

Whereas, 23 CFR 650 Subpart C, requires initial inspection of all bridges and reinspection at intervals not to exceed two years with the exception of reinforced concrete box culverts that meet specific criteria. These culverts are reinspected at intervals not to exceed four years.

Therefore: Perkins County is desirous of participating in the Bridge Inspection Program.

The County requests SDDOT to hire Brosz Engineering, Inc. for the inspection work. SDDOT will secure federal approvals, make payments to the Consulting Engineer for inspection services rendered, and bill the County for 20% of the cost. The County will be responsible for the required 20% matching funds.

<u>Fuel Pumps</u> –The diesel pump is still not working consistently at the shop. Schweitzer moved, Campbell seconded to replace the diesel fuel pump at a cost of \$12,496.00, which includes 2 - under pump plumbing kits (\$100.00), 1 - new wayme select gallons only single product/single hose, heater, pulse output suction pump green doors (diesel \$7,260.00), freight (\$200.00), installation, labor, milage, subsistence drivetime, shop supplies (\$4,936.00), motion carried.

<u>Surplus Equipment</u> – Henderson moved, Campbell seconded to surplus the Monroe Sander, Model: MCV-144-84-56.M, Serial: 14-05-7186, and 2000 Ford F-250, VIN: 1FTNF21LOYEB39018, motion carried. Foster moved, Schweitzer seconded to have Chairman Carmichael appoint 3 real property owners and to advertise the surplus property twice, motion carried.

<u>Surplus Office Printer</u> – Foster moved, Campbell seconded to surplus the Brother Model # MFC-L8900CDW as 3 real property owners found it to have no value, motion carried.
